

## **BareWild Terms and Conditions**

*Last Updated: January 29, 2026*

These Terms and Conditions (“Terms”) govern the use of the BareWild website and services (“BareWild,” “we,” “us,” or “our”). By accessing our website, uploading images, or placing an order, you agree to be bound by these Terms.

If you do not agree to these Terms, do not use our services.

---

### **1. Services Provided**

BareWild provides professional photo printing and related print services, including but not limited to photographic prints and specialty print products. Services are offered exclusively for lawful, consensual content involving adults.

BareWild reserves the right to modify, suspend, or discontinue any service at any time.

---

### **2. Eligibility**

By using BareWild services, you confirm that:

- You are at least 18 years of age.
- You are legally permitted to submit and print the images you upload.
- All individuals depicted in submitted images are **18 years of age or older**.
- All content is consensual, lawful, and not exploitative.

Content involving minors will not be printed and may be reported as required by law.

---

### **3. Customer Responsibility for Content**

You are solely responsible for the content you upload.

By submitting images to BareWild, you represent and warrant that:

- You own the image or have the legal right to reproduce it.
- The content does not violate any laws or third-party rights.
- The content does not depict illegal activity, non-consensual acts, or exploitation.

BareWild does **not** verify ownership, copyright, or licensing status of submitted images and relies on customer representations.

---

#### **4. Prohibited Content**

BareWild will not print or process content that includes:

- Images involving minors
- Non-consensual or exploitative material
- Content depicting illegal acts
- Content intended to harass, threaten, or harm others
- Content that violates applicable local, state, federal, or international laws

BareWild reserves the right to refuse or cancel orders at its discretion.

---

#### **5. Image Review and Access**

Images are accessed only as necessary to fulfill printing and quality control requirements.

BareWild does not:

- Browse images unnecessarily
- Use images for entertainment or marketing
- Share customer images externally
- Employ automated AI content scanning for moderation

Access is restricted to authorized personnel involved in order fulfillment.

---

#### **6. Data Security and Privacy**

BareWild employs industry-standard security measures, including encryption in transit and at rest, to protect uploaded files.

Images are not indexed, reused, or publicly displayed without explicit consent.

---

#### **7. Image Retention and Deletion**

Uploaded images are retained only as long as necessary to fulfill the order.

Unless otherwise agreed in writing:

- Images are automatically deleted **within 90 days** of order completion.
- Images that are uploaded but **not used in an order** are automatically deleted **within 90 days** of upload.
- BareWild does not provide long-term storage by default.

Requests for extended retention must be arranged in advance.

---

## **8. Watermarks and Image Alteration**

BareWild does not remove watermarks, ownership indicators, or copyright markings.

If an image is submitted with a visible watermark, it will be printed **as provided**.

BareWild will not alter images to bypass licensing, attribution, or copyright protections.

---

## **9. Humor, Gag, and Edited Content**

BareWild permits humorous, edited, or novelty images, including gag gifts, provided the content is lawful, consensual, and not exploitative.

Some product types may have limitations. If an order cannot be fulfilled as requested, customers will be notified before production.

---

## **10. Orders, Pricing, and Payment**

All prices are listed in U.S. dollars and are subject to change without notice.

Payment authorization is required at the time an order is placed. BareWild may authorize funds upon order submission and capture payment once the order enters processing.

By placing an order, you authorize BareWild to:

- place a temporary authorization for the full order amount
- capture payment when production begins

- adjust or release authorized amounts if items are removed or an order is cancelled while pending

Orders may be cancelled only while in a pending state. Once an order has entered processing or production, it cannot be cancelled.

Custom and specialty products may have different pricing, production times, or limitations.

BareWild reserves the right to cancel unpaid, disputed, or non-compliant orders.

---

## **11. Refunds, Cancellations, and Reprints**

Due to the custom nature of photo printing and specialty products, all sales are considered final once production begins.

- Orders may be cancelled while in a pending state. A cancellation or administrative fee may apply.
- Orders that have entered processing or production are **not eligible for cancellation or refund**.
- Printed items are not refundable due to material and production costs.

Reprints or partial refunds may be issued at BareWild's discretion if:

- a printing defect occurs
- an error is made during fulfillment

Refunds will not be issued for:

- customer dissatisfaction with content
- changes of mind after production begins
- content preferences or subjective quality concerns

BareWild's liability is limited to the cost of the affected item(s) only.

---

## **12. Shipping and Packaging**

Orders are shipped in discreet, unbranded packaging whenever possible.

Shipping labels are generated based on carrier requirements. While BareWild makes reasonable efforts to keep labeling neutral, in some cases the sender name may reference BareWild or a related business entity.

BareWild does not include descriptions of contents on shipping labels.

BareWild is not responsible for delays caused by shipping carriers, incorrect addresses, or circumstances beyond our control.

---

### **13. Communication**

BareWild does not provide routine phone support.

Customer communication is handled primarily through secure electronic channels. Contact forms and written communication are preferred to protect privacy and maintain records.

BareWild may contact customers directly if clarification is required.

---

### **14. Limitation of Liability**

To the maximum extent permitted by law, BareWild shall not be liable for:

- Indirect, incidental, or consequential damages
- Loss of data beyond reasonable security safeguards
- Customer misuse of printed materials
- Delays, errors, or failures caused by third-party services or carriers
- Customer misrepresentation regarding age, consent, or legality of submitted content
- Claims arising from copyright, trademark, or intellectual property infringement based on customer-submitted images

BareWild relies on customer representations regarding the legality, ownership, licensing, age, and consent of all submitted content. BareWild is not responsible for verifying these representations beyond reasonable operational review.

BareWild's total liability for any claim shall not exceed the amount paid for the specific order giving rise to the claim.

## 15. Indemnification

You agree to indemnify, defend, and hold harmless BareWild, its owners, employees, contractors, and affiliates from and against any and all claims, liabilities, damages, losses, costs, and expenses (including reasonable attorneys' fees) arising out of or related to:

- Content you submit, upload, or request to be printed
- Any misrepresentation regarding age, consent, ownership, or legality of submitted content
- Violation of these Terms
- Violation of any applicable laws or third-party rights, including copyright, trademark, or privacy rights
- Use, distribution, or display of printed materials after delivery

BareWild's acceptance or printing of content does not constitute endorsement or assumption of responsibility for such content.

## 16. Right to Refuse Service

BareWild reserves the right to refuse, suspend, or cancel service **at its sole discretion**, for any lawful reason, including but not limited to:

- Content concerns
- Violations of these Terms
- Abusive, threatening, or inappropriate behavior
- Misrepresentation or lack of cooperation
- Operational, safety, or business considerations

BareWild is not required to provide justification for refusal of service, provided such refusal is lawful.

BareWild may update these Terms at any time. Continued use of the service constitutes acceptance of the revised Terms.

These Terms are governed by the laws of the United States and the state in which BareWild operates, without regard to conflict-of-law principles.
