

## **BareWild Privacy Policy**

***Last Updated:*** January 29, 2026

BareWild (“BareWild,” “we,” “us,” or “our”) values privacy and discretion. This Privacy Policy explains how we collect, use, store, and protect personal information and uploaded content when you use our website and services.

By accessing or using our services, you agree to the practices described in this Privacy Policy.

---

### **1. Information We Collect**

We collect only the information necessary to provide our services.

#### **Information You Provide**

- Account information (such as name and email address)
- Uploaded images and files submitted for printing
- Order details and preferences
- Communications submitted through contact forms, email, and phone.

#### **Payment Information**

Payments are processed through third-party payment processors. BareWild does **not** store full payment card numbers or sensitive financial details on its servers.

### **2. Uploaded Images and Content**

Uploaded images are treated as **private customer property**.

BareWild:

- accesses images only as necessary to fulfill printing and quality control
- does not share images with third parties for marketing, analysis, or storage
- does not index, reuse, or publicly display images without explicit consent
- does not use automated AI systems to scan or moderate image content

Access to uploaded content is limited to authorized personnel involved in order fulfillment.

### **3. Image Retention and Deletion**

Uploaded images are retained only as long as necessary to fulfill orders.

Unless otherwise agreed in writing:

- Images associated with completed orders are deleted within **90 days** of order completion
- Images uploaded but not used in an order are deleted within **90 days** of upload
- BareWild does not provide long-term image storage by default

Extended retention may be arranged in advance for specific use cases.

### **4. How We Use Information**

We use collected information to:

- process and fulfill orders
- communicate about orders or support requests
- maintain site functionality and security
- comply with legal obligations

We do not sell personal information.

---

### **5. Cookies and Analytics**

BareWild may use essential cookies necessary for site operation and security.

We do not knowingly use tracking technologies designed to profile users based on uploaded content or sensitive material.

---

### **6. Data Security**

BareWild employs reasonable administrative, technical, and physical safeguards to protect information, including:

- encrypted file transfers

- access controls
- restricted internal access

No system is 100% secure, but we take privacy and security seriously and implement safeguards appropriate to the nature of the data.

## **7. Sharing of Information**

BareWild does not sell or rent personal data.

Information may be shared only:

- with service providers necessary to process payments or fulfill orders
- to comply with legal obligations
- to protect the rights, safety, or property of BareWild or others

Any sharing is limited to what is reasonably necessary.

## **8. Age and Content Responsibility**

BareWild relies on customer representations that:

- all submitted content involves legal adults
- all content is consensual and lawful
- the customer has the right to submit and print the content

BareWild does not knowingly collect information from minors.

## **9. Communications**

We primarily communicate through electronic means to protect privacy and maintain records.

BareWild does not provide routine phone support. We may contact customers directly if clarification or assistance is required.

## **10. Your Choices**

You may:

- request deletion of your account
- request clarification regarding stored information
- contact us with privacy-related concerns

Some information may be retained as required for legal, accounting, or operational purposes.
